- •Promote public awareness and enjoyment of the recreational path system and of the history, geology and biota of the West River valley.
- •Coordinate local, state and federal interests in planning, funding, construction, management and use of the trail system.

The Vermont Youth Conservation Corps

A crew of more than a dozen young people from the Vermont Youth Conservation Corps (VYCC) worked for three weeks in the summer of 2013 to install culverts, re-grade surfaces and mitigate erosion along the Trail.

The VYCC crew, Summer 7, was made up of two experienced and well-trained Crew Leaders and eight motivated 18-24 year old Corps Members. Throughout the season, this vibrant crew garnered a reputation as a healthy, balanced, fun, creative, energetic and determined group of young adults.

As we move toward spring, our trail shoes close at hand, we want to thank all those who have supported our programming and activities over the past year. The West River Trail is an outstanding recreational resource in our region – for individuals, families, students, athletes, of all ages and abilities. Also, other local and state non-profits, as well as private individuals, are making increasing use of the Depot and have established it as the vital community center we envisioned. It is available to everyone, and rental rates are kept reasonable to encourage its broad usage, to the benefit of all. And, of course, it is home to a growing list of free public events conducted annually by our own organization.

Several remarkable events were conducted at the Depot in 2013:

- •"Eleven Miles of Trouble," a trail run organized by and benefitting the Flood Brook Collaborative (to be repeated in 2014) headquartered at the Station.
- •Marlboro College Grad School's Center for Creative Solutions, a week-long conference with multiple state and regional partners on the topic of rebuilding Londonderry post-Tropical Storm Irene.
- •Trip Talks, armchair travel to points near and far via slides and stories shared by adventurous friends and neighbors who took us along to Patagonia and Cuba.
- •The FoWRT Annual meeting, "Doings at the Depot" in February 2013, was informative and well attended. All enjoyed hearing updates on upper and lower section accomplishments, the dedication of a locomotive bell generously donated by William and Agnes Peele, a preview and talk by Tim Lawrence of his video about hiking the West River Trail, delicious refreshments, and socializing together with old and new



NEWS FROM THE LOWER SECTION

It was a busy year for the Lower Section of the Friends of the West River Trail. Much was accomplished with the help of many, in our fundraising and trail improvement efforts.

Some of the 2013 highlights:

- •Volunteers cleared winter blow-down and removed several tons of abandoned cars, automotive parts, tires and other debris that had been dumped along the sides of the Trail several decades ago.
- •We achieved our initial goal of \$45,000 to fund Foundation Stage improvements to the Trail and embarked upon Enhancement Stage fundraising to support on-going trail restoration and additional opportunities for conservation and education.
- •In July, the inaugural FoWRT Run/Walk attracted 18 participants. Tim Fleming, organizer of the event, ran all the way from the Marina to the Townsend Dam!



THE WEST RIVER TRAIL: A TRAIL FOR ALL AGES AND ABILITIES

The Friends of the West River Trail continues fundraising to achieve our dream of improving the beautiful wooded lower six miles of the West River Trail for everyone, and eventually joining it with our Upper Section.

Our trail can be used by people of all ages: commuter bikers, families with children on bikes or in strollers, walkers, runners and cross country skiers. Our hope is to create a mobility-friendly surface for a walk—a gentle, flat bike ride, or a wheelchair outing. We've made many improvements and are on our way to achieving our dream. DONATE TO THE WEST RIVER TRAIL: http:// westrivertrail.org/ donate/ •With grants from the Vermont Housing & Conservation Board and the Vermont Land Trust, along with the help of local donors, FoWRT purchased the "Riverstone Preserve," a 21-acre tract of land along the West River about one mile north of the Marina. This ecologically diverse site is nestled between the river and the historic former West River Railroad corridor (See map).

•In conjunction with the I-91 bridge replacement project, updates on Trail accessibility are posted weekly in local media, on the West River Trail website and at the southern trail-head. Meanwhile, the Trail will remain accessible from Rice Farm Road to the Riverstone Preserve for the duration of the I-91 project.

•Local volunteers, including a youthful contingent from the Greenwood School, participated in fall clean-up along the entire length of the Lower Section.

THE LOWER SECTION: LOOKING AHEAD

Here are some future efforts we are looking to our Enhancement Stage funding to support:

- •Facilitate points of access to the Trail from additional locations such as Technology Drive and Fox Farm Road
- •Remove debris and abandoned material from the Riverstone Preserve
- •Form a team to design low-impact, environmentally



appropriate interpretative trails, signage, picnic areas and program space at the Riverstone Preserve

- •Repair foot bridges on the Trail upstream of the Preserve
 •Explore possibilities for linking the Trail to the Town of
 Brattleboro's West River Park, to the network of Trails behind
 the Retreat Farm and to the extensive rails-to-trails network in
 southwestern New Hampshire
- •Construct two new bridges and extend the trail northward 1.5 miles to the old granite quarry.






